**Format:** Up to 20 teams can participate. Format will include pool play and crossover matches. Games will be 25 minutes running time - no half time. Teams will be guaranteed a minimum of 5 games. Tourney will run from approx. 8 am to 6 pm. Prizes awarded for 1<sup>st</sup> place.

All games will be played 6 vs. 6 following the FIH Rules of Indoor Hockey 2005. See [www.usfieldhockey.com](http://www.usfieldhockey.com) for complete indoor rules.

**Venue:** 3 indoor courts at C.C.B.C. Essex, 7201 Rossville Blvd. Baltimore MD 21221

**Team Fee:** \$325 per team (plus a separate \$50 check for forfeit fee - this will be returned if your team does not forfeit any games). **Only 2 teams per club can participate.** Please make checks out to BFHA.

**Requirements:** All participants must be under the age of 19. All players and their parents must sign the attached waiver and photo release form. All participants must be USFHA members. If anyone is not currently a member, please go to [www.usfieldhockey.com](http://www.usfieldhockey.com) to sign up online. 2 team limit per club.

**Registration:** To reserve a spot for your team, please complete and return the attached Registration Form along with a \$325 registration fee and \$50 forfeit fee (separate checks, please) to the address shown. **Registrations will not be accepted over the phone or via e-mail.** Teams will be accepted in the order which registrations are received.

**Deadline:** All registration forms and fees must be submitted to the address below by January 7, 2012. However, there are a limited number of spots available so to guarantee your team a spot, please send in your registration and fee as soon as possible! There will be a \$50 late fee for any registration forms received after this deadline if spots are still available.

**Team Roster:** All teams must submit the final roster and team waivers by January 14, 2012.

**Cancellations:** If your team needs to cancel due to unforeseen circumstances, a full refund will be issued if made in writing prior to January 14, 2012. No refunds will be granted after the January 7th deadline.

From the North or South Via I-95

- I-95 to exit 64 (I-695 East) towards Essex. If you are coming from the south, this is the 2<sup>nd</sup> exit for I-695.
- Once you are on I-695 East, get immediately in the right lane
- Take the first exit (Exit 34) MD 7 - Philadelphia Road
- Make a left at the light at the end of the ramp onto MD 7 North
- Make a left on Rossville Blvd.(third light)
- C.C.B.C. Essex Campus will be on the right (After Franklin Square Blvd.)
- Follow the entrance road around to the back - the gym will be on your right

From the south via I-97

- Take I-97 north to I-895 north - this will be an exit on the left side of the road. (do not get on I-695 at this point- you must go through the tunnel first).
- Follow I-895 north through the tunnel. After the tunnel, I-895 will merge with I-95 north.
- After the merge with I-95, get in the right lane and take exit 64 - I-695 East towards Essex.
- Follow directions from above.

- Follow I-695 to exit 34 - MD 7- Philadelphia Rd. (just past I-695 interchange)
- Make a left at the light at the end of the ramp onto MD 7 North

- C.C.B.C. Essex Campus will be on the right (After Franklin Square Blvd.)
- Follow the entrance road around to the back - the gym will be on your right
