1. Go to <http://bfha.website.siplay.com/>
2. If you already have an SI Play account, click the log in button (top right corner). If not, create an account (sorry, we know it is, yes another new account. This is required to verify your USAFH membership.) Save your login information for future BFHA events.
3. Click the Icon: 'Register to Participate'

MUST BE COMPLETED BY ALL PLAYERS OF BFHAS BEACH BASH (to be submitted at Team Registration. Must be submitted to tourney director prior to first game)

In consideration of being allowed to participate in any way in the Baltimore Field Hockey Association (BFHA) programs, related events and activities, the undersigned acknowledges, appreciates and willingly agrees that:

1. I will comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
2. I acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which may result not only from their own actions, inactions or negligence but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, I accept personal responsibility for the damages following such injury, permanent disability or death; and,
3. I knowingly and freely assume all such risk, both known and unknown, even those arising from the negligent acts or omissions of others, and assume full responsibility for my participation; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless USA Field Hockey, the Baltimore Field Hockey Association (BFHA), and the Cape Henlopen School District its officers, officials, affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event, all of which are hereinafter referred to as "releasees," with respect to all and any injury, disability, death or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
